Description of correction: Format incorrect. Should read:


Performed all together

Description of correction: Changed ankle flexed from left leg to right leg in bar 1 beat 2. Word notes are unaffected. Benesh notation amend highlighted in yellow

Music A: And ante con moto Φ per J (1 bar of notation = 1 music bar)

Music B: Andante con moto per . (1 bar of notation = 1 music bar)



Primary in Dance

P26 - P2: Legs and Feet (February 2015)

Examination: Performed two at a time (3 candidates all together)

Class Award: all together, teacher's choice of formation

P28 - P3: Arms and Head - Music A (February 2015)

P46 - P11: Galops and Skips - (February 2015)

Description of correction: Format incorrect. Should read:

Examination: Performed all together with or without a partner Class Award: Up to four candidates: Performed all together

Five or more candidates: Performed in two groups

P46 - P12: Run and Leap - (February 2015)

Description of correction: Addition to format information:

Examination: One after the other continuously

Class Award: Up to four candidates: one after the other continuously

Five or more candidates: two at a time (plus one if necessary) continuously

P52 – P14: Dressing-Up Dance (amended June 2011)

Description of correction: Candidates perform the Dressing-up Dance two at a time in the examination and up to four candidates at a time in the Class Award. A small trunk, suitcase or box with hinged lid should be provided for <u>each</u> candidate. The only choice for the dressing-up item is head-gear (e.g. hat or tiara) or neckwear (e.g. scarf, feather boa, etc.)
