How Long We Keep Your Data

Your personal data will be retained for no longer than necessary for the purposes described above. Marketing data will be retained until you opt out.

Your Rights

- **Erasure:** Request deletion of your data where it is no longer necessary.
- **Objection:** Object to processing for marketing purposes.
- **Data Portability:** Request transfer of your data to another service provider.
